

PUBLIC OFFER OF AMAROSE MUSIC

for custom song creation services

1. SUBJECT OF THE TERMS

AMAROSE Music provides a service for creating a personal custom song based on information provided by the client through the Telegram bot, email, website, or another official project channel.

The song may be created for a birthday, love story, wedding, anniversary, family moment, gratitude, apology, memorial occasion, or another personal event of the client.

AMAROSE Music does not copy other peoples songs, lyrics, music, voices of famous artists, or protected materials. Each order is created as an individual work based on the story and wishes of the client.

2. ORDER PROCESS

To place an order, the client answers questions in the Telegram bot or sends information through an official AMAROSE Music channel.

The client may specify: who the song is for, the occasion, names, important details, desired emotions, style, language of the song, and additional wishes.

The client is responsible for the accuracy of the information provided. If the client provides incorrect names, dates, facts, or details, AMAROSE Music is not responsible for such errors in the result.

3. DEMO FRAGMENT

Before payment, the client may receive a demo fragment of approximately 20-30 seconds.

The demo fragment is created for preliminary review of the musical direction and mood.

The demo fragment is not the full final song and may differ from the final version in structure, duration, arrangement, sound processing, and details.

AMAROSE Music reserves the right to limit the number of free demo fragments to avoid misuse or unreasonable use of project resources.

4. PACKAGES AND PRICES

Current AMAROSE Music packages:

1 song — \$15

3 songs — \$39

4+ songs — \$12 for each song

Prices may be updated by AMAROSE Music in the future. The current price is shown on the website, in the Telegram bot, or in an official project message at the moment of order confirmation.

If the client needs urgent preparation, an additional urgent delivery fee may be discussed separately.

5. PAYMENT

The full song is created after order confirmation and payment of the selected package.

Payment means that the client agrees with these Terms and confirms the intention to receive the full song.

After payment, AMAROSE Music starts creating the full song based on the agreed information.

6. DELIVERY TIME

Preparation time for a demo and full song depends on project workload, order complexity, number of songs, language, style, and volume of client wishes.

Usually the demo fragment is prepared faster than the full song.

Exact delivery dates may be discussed individually in the Telegram bot, support, or another official AMAROSE Music channel.

7. REVISIONS

After receiving the result, the client may request reasonable revisions to lyrics, mood, details, names, individual words, or general direction of the song.

Revisions are performed within a reasonable scope and within the limits of the original order.

If after the start of work the client completely changes the topic, style, story, recipient, or requests a practically new song, such work may be considered a new order and may be charged separately.

8. REFUNDS

Because the song is created individually for a specific client, refunds after work on the full song has started may be limited.

If the client paid for an order, confirmed the information, and AMAROSE Music started creating the full song, the service is considered an individual creative work.

Each disputed situation is reviewed individually through AMAROSE Music support.

AMAROSE Music may offer a revision, replacement of the result, partial solution, or another reasonable resolution if the problem was caused by the project.

9. RIGHTS TO MATERIALS

The client confirms that all information provided for the song is given voluntarily.

The client must not provide materials that violate third-party rights, including other peoples lyrics, songs, music, recordings, commercial phonograms, voices of famous artists, or materials protected by copyright.

AMAROSE Music creates the song as an original custom work based on the client story and wishes.

The client receives the right to use the delivered song for personal listening, as a gift, sending to close people, and publishing on personal social media pages, unless otherwise agreed separately.

Commercial use of the song, advertising, sale, placement in commercial projects, or use on behalf of a company may require separate agreement with AMAROSE Music.

10. LIMITATIONS

AMAROSE Music does not create materials containing insults, threats, incitement to hatred, illegal content, calls for violence, harmful materials, violation of rights of third parties, or requests to copy famous artists, songs, or voices.

AMAROSE Music has the right to refuse to perform an order if it conflicts with the project rules, law, ethics, or may violate the rights of other people.

11. PERSONAL DATA

The client provides AMAROSE Music with data voluntarily, only for placing and completing the order.

AMAROSE Music may use the provided data to process the request, create the song, communicate with the client, clarify order details, support the client, and fulfil obligations connected with the order.

AMAROSE Music does not sell client personal data and does not transfer it to third parties without necessity for completing the order or a legal basis.

These Terms apply to all orders placed through official AMAROSE Music channels.

The client confirms acceptance of the Terms when starting the bot, sending a request, providing data for a song, or paying for an order.

If the client does not agree with these Terms, the client should not place an order and should not make payment.
