

CONSENT TO PERSONAL DATA PROCESSING

1. DATA OPERATOR

The data operator is AMAROSE Digital LLC, AMAROSE Music project.

2. DATA PROVIDED BY THE CLIENT

The client may voluntarily provide information necessary for preparing and completing an order.

This may include: name, Telegram account, email, information about the recipient of the song, names, dates, events, family or personal details, wishes regarding lyrics, style, language, and mood of the song.

AMAROSE Music does not require unnecessary information and asks the client to provide only what is truly needed to create the song.

3. PURPOSE OF PROCESSING

The information is processed to receive an order for a personal custom song.

The purposes include: accepting the request, clarifying details, preparing a demo fragment, creating the full song, communicating with the client, providing support, processing payment-related information, storing the order history, and handling reasonable questions or requests.

4. ACTIONS WITH DATA

AMAROSE Music may collect, record, organize, store, clarify, use, transfer within the limits necessary for the order, anonymize, block, and delete data.

Processing may be carried out using digital services, messengers, email, file storage, payment tools, and other technical means necessary for the work of the project.

5. CONSENT PERIOD

Consent is valid from the moment the information is provided and until the purposes of processing are achieved or until consent is withdrawn by the client, unless further storage is required by law, accounting, technical, or contractual reasons.

Some information may be kept to confirm the order, payment, service fulfilment, handle claims, or protect the rights of AMAROSE Music.

6. DATA TRANSFER

AMAROSE Music does not sell clients personal data.

Transfer to third parties may be possible only to the extent necessary for completing the order, processing payment, providing technical service, storing files, communicating with the client, or complying with legal requirements.

The client understands that website, Telegram bot, email, and payment services may use external platforms.

7. WITHDRAWAL OF CONSENT

The client may withdraw consent by contacting AMAROSE Music by email or through Telegram support.

After receiving the request, AMAROSE Music will consider whether deletion or restriction of processing is possible, taking into account an already started order, technical limitations, and legal grounds for storage.

Withdrawal of consent may make further completion of the order impossible if the data is necessary to create the song or communicate with the client.

8. CLIENT RESPONSIBILITY

The client confirms that the information is provided voluntarily and that the client is responsible for its accuracy.

The client must not provide personal data of third parties without consent if such data is sensitive or may affect the rights of other people.

If the client provides information about another person for the purpose of creating a song, the client confirms that they have the right to use that information within the order.

9. DATA PROTECTION

AMAROSE Music takes reasonable measures to protect information from unauthorized access, loss, modification, or disclosure.

Access to information is limited to people and services necessary for completing the order and supporting the client.
